# City of Corinth Unified Development Code Section: 2.07.04.A.4.ii.

## Chickens are permitted as household pets within all residential lots, subject to the following requirements:

- (a) No more than four hens are permitted,
- (b) Roosters are prohibited, and
- (c) A permit is required to keep chickens.

#### Pens or Enclosures for Chickens as Household Pets within Residential Zoning Districts

Pens or enclosures for chickens as household pets are permitted on all residential lots and shall meet the following standards.

(a) Setbacks:

- 1. Front Setback: Behind the front building line;
- 2. Side Setback: 30 feet from the side lot line; and
- 3. Rear Setback: 20 feet from the rear lot line.
- (b) Proximity to Owner's House:
  - 1. Enclosures must be within 10 feet of the house.
- (c) Maximum Enclosure Size:

1. Four feet by ten feet.

2. These pens or enclosures are not subject to any masonry requirements.

#### **Household Chicken Permit**

- 1. A person commits an offense if the person maintains or keeps chickens without having obtained a permit from the City.
- 2. A person shall apply to the Director of Planning for a permit to keep chickens. The Application shall be submitted on a form provided by the City and include such information as is specified to ensure the applicant complies with City ordinances.
- 3. The City Manager shall issue a permit if the applicant meets all requirements of the UDC and other applicable City ordinances.
- 4. In the event a permit holder violates the requirements of the UDC or other applicable ordinance, the City shall revoke the permit.
- 5. The permit holder may appeal the revocation to the City Manager within five days of receipt of the notice of revocation, and shall state the basis for the appeal. The City Manager shall consider the evidence and determine, by a preponderance of the evidence, if the revocation should be upheld. The determination of the City Manager is final.

## Obtain a Copy of your Plot Plan

Obtain a copy of your plot/survey plan from the City, or if you already have one, indicate distances from the coop to building and property lines-then submit it with the application. This will help ensure your proposed chicken coop will be within the required setbacks.

#### **Build the Chicken Coop**

Once you receive approval from the City, you are now authorized to build the chicken coop within the required setbacks as illustrated on your application and ordinances. Please see attached requirements.

#### Submit the Household Chicken permit application

Once you have completely filled out the permit application and provided the details about the proposed chicken coop, submit the permit to the City for review. There is no fee for the permit.

#### **Chicken Coop Inspection**

Once you have completed construction, please contact the Building Permits office to schedule an inspection.

#### **Final Approval**

After inspection and review of the application you will receive a final approval of the construction if it meets all ordinance and code requirements.

#### **Stock Coop with Chickens**

Once you receive final approval, you are welcome to acquire up to four (4) chickens. Roosters are not permitted. It is also important to remember that only actual chickens are permitted. Ducks, turkeys, Guinea Hens, and other similar fowl are not permitted.
