

#### **KEY TRENDS**

#### Description

The sales tax in Corinth is 8.25% for goods and services sold within the City's boundaries. The tax is collected by businesses making the sale and is remitted to the State Comptroller of Public Accounts on a monthly, and in some cases, quarterly basis. Of the 8.25%, the state retains 6.25% and distributes 1% to the City of Corinth, .25% to the Street Maintenance Sales Tax Fund, .25% to the Crime Control & Prevention District and .50% to the Economic Development Corporation. The State distributes tax proceeds to local entities within forty days following the period for which the tax is collected by businesses.

As required by the Government Accounting Standards Board, sales tax is reported for the month it is collected by the vendor September 2018 revenues are remitted to the City in November 2018. Sales Tax received in September represents July collections.

#### **Analysis**

The EDC Sales Tax revenue reflects a year-to-date increase in collections compared to the budgeted amounts.


Revenues are deposited into the Economic Development Corporation Fund and must be used on behalf of the city in carrying out programs related to a wide variety of projects including public parks and business development (Tex.Rev.Civ.St. art 5190.6-the Development Corporation Act of 1979).



#### **KEY TRENDS**

#### **Description**

The sales tax in Corinth is 8.25% for goods and services sold within the City's boundaries. The tax is collected by businesses making the sale and is remitted to the State Comptroller of Public Accounts on a monthly, and in some cases, quarterly basis. Of the 8.25%, the state retains 6.25% and distributes 1% to the City of Corinth, .25% to the Street Maintenance Sales Tax Fund, .25% to the Crime Control & Prevention District and .50% to the Economic Development Corporation. The State distributes tax proceeds to local entities within forty days following the period for which the tax is collected by businesses.

As required by the Government Accounting Standards Board, sales tax is reported for the month it is collected by the vendor November 2018 revenues are remitted to the City in January 2019. Sales Tax received in November represents September collections.

#### **Analysis**

The EDC Sales Tax revenue reflects a year-to-date increase in collections compared to the budgeted amounts.


Revenues are deposited into the Economic Development Corporation Fund and must be used on behalf of the city in carrying out programs related to a wide variety of projects including public parks and business development (Tex.Rev.Civ.St. art 5190.6-the Development Corporation Act of 1979).

#### AGENDA ITEM SUMMARY/BACKGROUND

Several projects have been presented to the Board of Directors of the Corinth Economic Development Corporation (the "CEDC") to stimulate economic regeneration and activity in Corinth. In particular, those projects have focused on: (i) the extension of Parkridge Drive northward to Church Street; (ii) exploring the feasibility of tax increment reinvestment zone to attract commercial and mixed-use development along the Interstate Highway 35E Corridor in proximity to Corinth Parkway; (iii) the acquisition of surplus right-of-way from the Texas Department of Transportation ("TxDOT") at the four quadrants of the Interstate Highway 35E and Corinth Parkway Interchange; and (iv) other related transportation and infrastructure projects.

Additionally, staff prepared and submitted a response to Project Rose as advertised by the Dallas Regional Chamber of Commerce --- an international light manufacturing company that falls into the food packing category promising to employ between 60 - 100 people at their new location and make a capital investment of between \$40 - \$50 million --- on January 31, 2019.

The purpose of the update is to provide the Board of Directors with a status report that will further inform future actions and efforts.
