I further do hereby expressly RELEASE, DISCHARGE AND HOLD HARMLESS The City of Corinth, Lake Dallas ISD, Denton ISD, its employees, agents, successor s, assigns, sponsors and volunteers from any and all damages, claims or liability of any kind, whatsoever, from any injury or death to my child or damage to my or my child's property, arising or resulting from my child's participation in City activities or transporting of my child to and from City activities, or my child's presence upon the City of Corinth, Lake Dallas ISD, Denton ISD property and/or facilities, INCLUDING, BUT NOT LIMITED TO, CLAIMS AND DAMAGES ARISING IN WHOLE OR IN PART FROM THE NEGLIGENCE AND/OR GROSS NEGLIGENCE OF THE CITY, ITS EMPLOYEES, AGENTS, SPONSORS AND VOLUNTEERS.

For the consideration stated above, I further agree that in the event that my child repudiates or attempts to repudiate this release and/or the release signed by my child, I will personally IDEMNIFY AND HOLD HARMLESS the City of Corinth, their employees, agents, successors, assigns, sponso rs and volunteers for any and all lose and damages occasioned by such repudiation.

I recognize that all classes or activities of a physical nature involve some risk and by registering my child for class/activ ity of the City, there is an assumption of risk by me and my child.

I further authorize the City employee or agent supervising this activity to secure medical care for my child in the event of injury and in my absence. I hereby agree to assume liability for payment, and hold harmless the City, its employees or agents, of medical expenses arising from said medical care for said injury. \_\_\_\_\_ (initial here)
